



A year in Review CLHO 2017-2018

Major milestones and accomplishments

This has been quite a year. Kudos to the Coalition of Local Health Officials (CLHO) Board of Directors who have overseen quite a bit of work this year with, and on behalf of, the 34 local health departments throughout Oregon.

CLHO organizational accomplishments for the 2017-18 Fiscal Year:

- Successfully managed and completed and met all of the deliverables of the largest grant CLHO has ever received (\$249,000 – two year grant)
- Hired a new CLHO Program Manager
- Held the largest CLHO Retreat in recent history with 27 of 34 members available to attend
- CLHO Program Manager has conducted nine site visits
- Secured \$20,000 through a new grant funding opportunity and partnership with the University of Washington
- Reinstated monthly newsletters and county spotlights on CLHO website

Conference Committee Restructuring Support:

- Supported CLHO Committee restructuring process
- Recruited new committee members
- Trained committee staff to use the CLHO website for committee materials

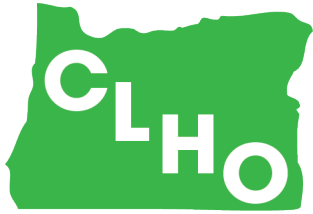
Modernization Implementation / Local Health Department Support:

- Oversaw development of www.orphroadmap.org supporting Modernization Implementation
- Over 35 tools developed or collected as resource to implement modernization
- Held four webinars about modernization tools which had 90 webinar participants from 23 counties
- Worked with Rede Group to provide TA to 12 counties

Policy Analysis, Review and Support:

- Health Care/ Public Health workshop – 18 participants from 14 LHDs made recommendations for CCO 2.0
- Reviewed 10 administrative rule drafts and provided analysis for local public health to review

- Provided public comments to: Cleaner Air Oregon administrative rule process; Modernization administrative rule process; and CCO 2.0 contract feedback at the Public Health Advisory Board & Oregon Health Policy Board

Workforce Development:

- Co-facilitated Accreditation Workgroup monthly calls in partnership with PHD
- Continued to support newer administrators through monthly calls and webinars focusing on areas of interest
- Facilitated communications workgroup: developed Public Health Accomplishments one pager and Oregon Communications Plan

Participate in strong coalitions & partnerships with:

2. Local Governmental Advisory Committee (now on hiatus)
3. Healthy Kids Learn Better
4. Oregon Partners for Tobacco Prevention

Legislative policy and funding accomplishments:

- First time funding (\$5 million) for Public Health Modernization
- \$10 million in funding for the Reproductive Health Equity Act
- Raising the age of sale of tobacco and nicotine products from 18 to 21
- Requiring insurance companies to cover vaccines during a public health emergency
- No reductions in funding for State Support for Public Health, drinking water and Babies First!
