Subject: Foodborne Illness Prevention Program 2019-21 Remittance Factor Calculation

The Oregon Health Authority (OHA) appreciates the meetings that took place March 6 and 7 with leadership of the Conference of Local Health Officials (CLHO) Environmental Health Committee and the Caucus of Environmental Health Supervisors (CLEHS). As requested, OHA is providing summary information about the remittance factor OHA has adopted for year one of the 2019-2021 biennium.

According to Oregon Administrative Rule (OAR) 333-012-0057, the Local Public Health Authority must collect fees from food service establishments and remit to the Authority the monies necessary to maintain the Foodborne Illness Prevention Program (FIPP). The Authority must consult with representatives of local health officials in determining the amount to be remitted by each Local Public Health Authority (LPHA) to support the state FIPP.

The remittance amount must be determined by first projecting statewide food service license revenue for the biennium using state marker fees. Then, the biennial budget of the FIPP is divided by the revenue projection to yield a percentage factor. Each Local Public Health Authority's revenue projection for food service facilities, using state marker fees, is then multiplied by that factor to yield the remittance amount.

The total annual cost to implement the FIPP is \$1,025,276. The total annual statewide revenue projection is \$5,891,104. \$1,025,276 divided by \$5,891,104 = 17.4%

## Reasons for increased costs:

- Staff salaries increased in 2018 (additional step added to classification).
- Increased salary results in increased direct and indirect charges.
- Indirect costs were budgeted at close to 17% for the current biennium but were actually around 27%. The proposed remittance factor reflects a more realistic estimate.
- The remittance factor for the current biennium (2017-19) is 10.88%. As shared with the Caucus of Local Environmental Health Supervisors (CLEHS) at the time of the 2017-19 factor adoption, OHA rectified earlier program deficits with a transfer of general funds

that resulted in the program having a positive cash balance at the start of the biennium. This positive balance allowed adoption of an artificially low remittance factor. Program costs depleted that cash balance, and OHA is projecting a \$142,935 shortfall at the end of the current biennium. OHA included this shortfall in calculating the total program cost of \$1,025,276 (Annual cost from July 1, 2019-June 30, 2020).

 OHA added a three-month operating reserve to the total program cost. At \$70,652 a month, this total is \$211,957. The budget assumes half of this amount (\$105,979) is collected in each half of the 2019-2021 biennium.

## **Future Considerations**

- OHA will need to revise the remittance factor if SB 28 passes into law during the 2019 legislative session. SB 28 proposes an increase to statewide food service licensing fees. This would impact the statewide revenue projection upon which the remittance factor is based.
- OHA will also need to further revise the remittance factor to reflect the additional cost OHA will assume for HealthSpace, the statewide licensing and inspection software. These costs will be added to the FIPP budget for the second half of the 2019-2021 biennium. The annual cost is estimated to be \$86,000. Lane County currently has the contract with HealthSpace and has agreed to pay the licensing fees in 2019. OHA will cover this cost starting in 2020.
- OHA is committed to providing a preliminary remittance factor to LPHAs in September of 2019. The preliminary remittance factor information will allow LPHAs to incorporate these costs into their respective budgets. Consistent with OAR, OHA would recalculate and adopt a final remittance factor by April 2020 which would take effect in July 2020.
