Oregon Turnkey Partnership

- Locally driven, statewide supported initiative to shelter vulnerable Oregonians in hotels/motels in response to the COVID-19 pandemic
- Mission is to mitigate transmission, reduce hospital surge, and protect lives, with a focus on sheltering Oregonians experiencing homelessness
- Technical assistance and guidance needed to support local partnerships to identify sites, funding, troubleshoot logistics, and provide services

Non-congregate shelter refers to the sheltering of vulnerable populations who need space for social isolation and is a best practice for sheltering people to prevent the spread of COVID-19

Medical Shelter

- For COVID-19 symptomatic, positive, or respite (post hospital) care used for sheltering and isolating COVID positive patients who are discharged from a more acute site, like a hospital, and need continued monitoring and low levels of medical care.
- These facilities may be particularly relevant for individuals who normally reside in a congregate setting, such as a homeless shelter, and need medical treatment and monitoring to fully recover.

Non-medical Shelter

- Individuals who have underlying health conditions, are medically fragile, over 65, or are otherwise considered to be at risk of contracting the virus.
- Individuals who have been exposed to the virus but have not tested positive or begun to exhibit symptoms. These individuals may need to be quarantined for a period of time until it is determined that they have not contracted the virus.
- Farmworkers needing new housing options to comply with the public health physical distancing guidelines and rules for farmworker housing under OSHA.
- Individuals experiencing homelessness who cannot maintain social distancing in congregate shelters or outdoor/camping settings
