The Systems and Innovation Committee provides guidance and recommendations for the implementation and improvement of system-wide work as it relates to the core-functions and requirements of public health modernization.

- 2) Has your committee met during the last year? If yes, what topics did your committee address?
 - Monthly in 2022
 - Revised program element 51 for modernization funding
 - Reviewed modernization funding formula
 - Ways to support improved communication between OHA and LPHAs by developing consistent approaches throughout system
 - Communities of practice
 - Monthly meetings
 - Liaisons, etc.
 - Working to develop guidance and template for local plans on full implementation of public health modernization
- 3) How has your committee discussed or incorporated Public Health Modernization as it pertains to your committee's objectives?
 - Our committee objectives are specific to public health modernization, so every discussion and project is aimed at supporting full implementation of Public Health Modernization.
- 4) When the CLHO Committees were restructured in 2018, each committee was asked to develop a charter and work plan. How are those materials working for your committee? Are you meeting your work plan objectives?

- We must review the Charter and see if this is still relevant. We follow basic meeting standards such as making sure that we have quorum prior to decision making.
- One rule we might want to put forward is to ensure that if in any committee –
 there is multiple staff representing one county, only one vote per county should be
 counted.
- The workplan has been reviewed and our focus is on developing a guiding document and possible template for the local modernization plan due in 2025.
- 5) How are you sharing meeting materials with committee members?
 - We try to send them ahead of the meeting
 - We recently gained access to the website and have posted meeting materials and minutes back to May 2022. Going forward, information will be maintained on the website in a timely manner.
- 6) How are you ensuring the CLHO Board (i.e. health administrators) receive relevant updates from your committee?
 - We bring to the board any question we might have for example we intend to
 engage the board with our initial plan and ideas for the local modernization
 guidance and plan requirement we will be developing to ensure that we have buyin and can answer questions and get feedback from the board on the direction we
 are taking.

Our committee is routinely assigned new tasks for review and input. For the remained of this fiscal year, while we focus on development of the modernization plan due in 2025, our capacity for additional assignments is reduced to ensure we can complete this high priority project.

In addition, frequent requests to our committee to review items that do not always align with our committee purpose add challenges to our ability to remain focused on larger system wide projects.
