COVID-19 School Recovery Intro

- The secondary and tertiary crises of the pandemic are playing out in schools today.
 - Deepening health inequities
 - Behavioral health needs
 - Social and economic needs
 - Staffing burnout
- CDC Cooperative Agreement provided flexible opportunity to increase school-based capacity.
- Engaged Schools, SBHCs (LPHA/Medical Sponsors), CBOs (some doing youth engagement) for recovery investment strategy.





COVID-19 School Recovery Funding

- \$1.5 million to SBHC Medical Sponsors
- \$1.5 million to School Districts
- \$2 million to CBOs
- \$1 million to youth engagement/ youth led investment





COVID-19 SBHC Recovery Funding

- \$1.5 million to increase workforce capacity in schoolbased health and recovery services.
 - New staff, additional hours, training
 - Flexible professional types/roles
- Up to \$150K per SBHC Medical Sponsor
- Funding runs through June 30, 2023
- Applications due November 19, 2021





COVID-19 SBHC Applicants

- 13 applicants
- Types of positions requested:
 - Community Health Workers
 - Outreach and Engagement Coordinators
 - Admin Support
 - Behavioral Health Staff
 - Pipeline work and recruitment/retention
 - Youth Interns





COVID-19 SBHC Funding Award Mechanisms

- 2019 State SBHC Program funding policy change:
 - LPHA first right of refusal for State SBHC funding
 - If refused, State SBHC Program may contract directly with SBHC medical sponsor agency
- COVID-19 SBHC funding disbursement will follow same mechanism
 - For LPHAs under PE 44-03
