Opioid Settlement Update

- Oregon Attorney General litigated multiple settlements on behalf of Oregon
- Two national settlement agreements reached in July 2021
 - Distributor settlement (McKesson, Cardinal Health, Amerisource Bergen)
 - Johnson & Johnson / Janssen Pharmaceuticals (J&J)
- Other litigation is still pending
 - Purdue Pharma (agreement reached – distributions pending bankruptcy)
 - There may be additional settlements
- Four separate tribal opioid settlements (Distributor/J&J settled)
 - Total of nearly \$590 million for all Federally Recognized Tribes

J&J / Distributor Agreement

- Nationwide settlement agreement reached in July 2021
 - Details at www.opioidsettlement.com
- Oregon agreement between state, cities & counties reached in late 2021
- Estimated total of >\$333 million coming to Oregon
 - 55% to Subdivision Fund
 - paid directly to cities and counties (pop. >10,000)
 - Allocation decisions are made locally
 - 45% to State of Oregon Opioid Settlement Prevention, Treatment & Recovery Fund
 - Approx. \$150 million in 18 payments, spring 2022 through 2038
 - Allocation decisions made by a board

Oregon Settlement Prevention, Treatment & Recovery Board

- Created by 2022 House Bill 4098 based on Oregon agreement
- Administered through OHA
- 18 members
 - 1 Governor's office, 3 state agency representatives
 - BM 110 Oversight & Accountability Council, Alcohol & Drug Policy Commission
 - 2 county representatives
 - 1 - Clackamas, Washington or Multnomah
 - 1 - Clatsop, Columbia, coos, Curry, Jackson, Josephine, Lane or Yamhill
 - 3 city representatives
 - Portland
 - City with population > 10,000
 - City with population < 10,000

Oregon Settlement Prevention, Treatment & Recovery Board

OSPTR Board membership, continued:

- 1 **Coalition of Local Health Officials** representative
- 1 community mental health program representative
- 1 person with or representing lived experience of substance use disorder
- 1 law enforcement, first responder, or jail commander/warden representative
- 1 State Senator, 1 State Representative (non-voting)
- 1 State Court Administrator (non-voting)

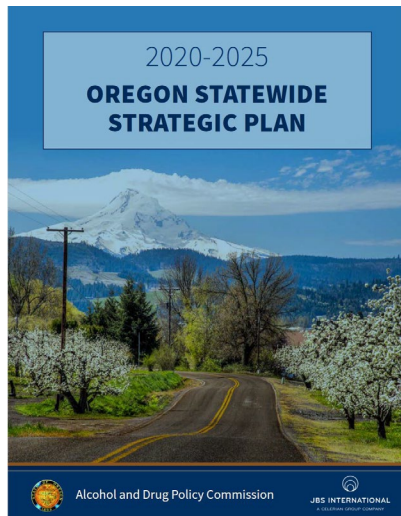

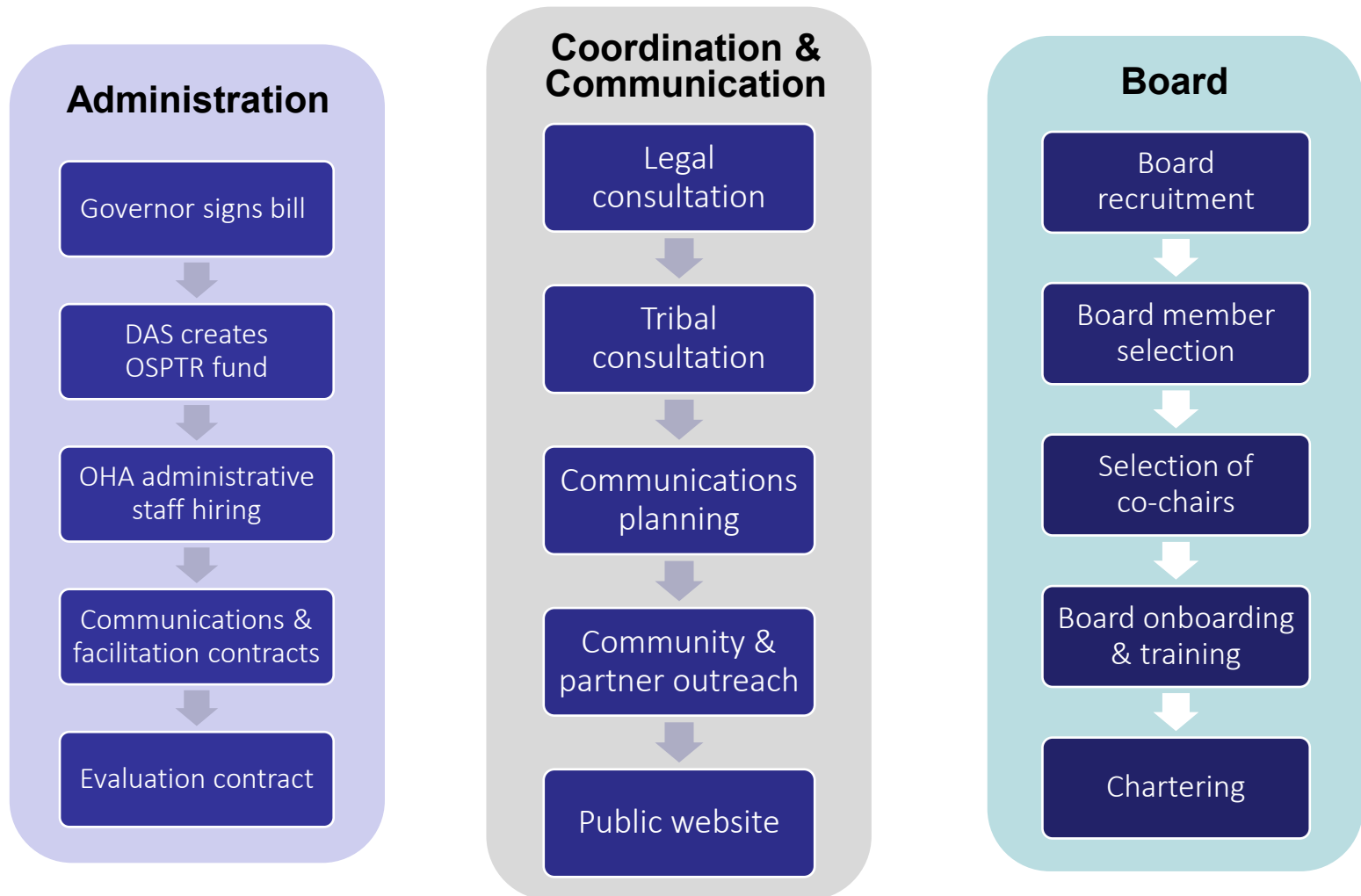
HB 4098 also requires...
