## Conference of Local Health Officials, September 21st, 2023

The Nominating Committee (Florence Pourtal, Bob Dannenhoffer, and Jennifer Little) met on September 13th, 2023 to discuss candidates for the CLHO Executive Committee Election and the process for voting (per the Conference of Local Health Officials Bylaws and the Coalition of Local Health Officials Bylaws).

- All current representatives are running for their positions again.
- Because of this, the Nominating Committee will not be doing active outreach to seek more candidates, but CLHO members who are interested in running can reach out and be added to the ballot.
- Nominations can also be made from "the floor" (at the Conference meeting but before voting on October 19th).
