Committee: Environmental Health

1) What is the purpose of your committee (please include the issues that are within your committee's purview)?

To provide guidance and recommendations for areas related environmental health regulations; licensing and inspections; planning and assessments related to environmental public health; development of environmental public health policy and programs; promotion and outreach around mitigating environmental health risks, and consultation. Including:

- Drinking water
- EH IGA
- Domestic Well Safety
- PH modernization- Climate and Health
- Brownfield assessment and redevelopment
- Lead
- 2) Has your committee met during the last year? If yes, what topics did your committee address?

Yes, the committee meets once monthly. Topics the committee has addressed include:

- HealthSpace and HealthSpace cloud issues
- Remittance letters and fees
- Climate and health adaptation planning
- Water quality including domestic well safety, harmful algal blooms
- OHA program staffing
- Cooling resources from OHA (portable AC units) and ODOE (residential heat pumps)
- Plan review for mobile units
- Statewide EH health indicators and accountability metrics

- Legislative issues and policy option packages
- 3) How has your committee discussed or incorporated Public Health Modernization as it pertains to your committee's objectives?

The committee discusses and reviews non-regulatory areas of work such as Healthy Home programs, lead screening questionnaires and investigative guidelines, climate and health adaptation planning, and water quality issues such as harmful algal blooms and cyanotoxins, to name a few.

- 4) When the CLHO Committees were restructured in 2018, each committee was asked to develop a charter and work plan. How are those materials working for your committee? Are you meeting your work plan objectives?
 - Co-chairs reviewed the charter the in spring and use it to develop agenda topics. The charter focuses on expanding environmental health work to meet the work outlined in PHM; that has been the focus of committee work for the past year.
