Alcohol & Drug Policy Commission Proposal

On May 8, 2024, the OSPTR Board approved an <u>ADPC proposal (link)</u> to increase and strengthen Oregon's workforce capacity for primary substance use disorder prevention

Settlement Board-Approved Motion

I move to allocate \$13,706,000 to the Oregon Health Authority (OHA) for primary substance use disorder prevention. This allocation is subject to the following conditions:

- Prior to awarding any funding, OHA must engage the <u>partners listed in the proposal</u> and provide a proposed funding formula and implementation plan, including identification of specific grantees to the Board for approval no later than September 4, 2024
- OHA must pass through these funds to the grantees listed in the Board-approved implementation plan in the amounts specified in the proposal.
- OHA must ensure that funds are expended in accordance with Board Exhibit E (Approved Strategies)
- OHA must monitor grantees receiving Board-allocated funding
- OHA will periodically provide reports to the Board

<u>Partners listed in the proposal for the \$9.5 million for Oregon counties:</u> 1) the Conference of Local Health Officials, 2) non-local public health prevention grantees, 3) the ADPC Prevention Committee, 4) the Addictions and Mental Health Planning and Advisory Council, and 5) OSPTR Board liaisons

OHA Progress: Funding to Counties (\$9.5M)

Formed Core Team, hosting weekly meetings

Email communications and presentations to local partners

Developed a Partner Engagement Plan and timeline

Contracted with PRR, Inc. to plan and facilitate Ambassador Team meeting

Recruited Ambassador Team members

Drafted allocation scenarios and resource materials for the Ambassador Team



Ambassador Team

OHA is using an Ambassador Model to determine the funding formula and implementation plan, where each of the five partner networks select up to four Ambassadors to represent their interests on an Ambassador Team

 1) the Conference of Local Health Officials, 2) non-local public health prevention grantees, 3) the ADPC Prevention Committee, 4) the Addictions and Mental Health Planning and Advisory Council, and 5)
 OSPTR Board liaisons

Ambassadors must attend all four Ambassador Team meetings (June 17-July 17)

Ambassadors are responsible for engaging their partner networks to inform their representation

CLHO Ambassadors were required to include at least one LPH Administrator

PRR will distribute an after-meeting summary following each Ambassador Team meeting

September 4: OHA will present the final proposal to the OSPTR Board
