Agenda Items

Legislative Session Update | Informational | Sarah Lochner, CLHO ED; Ryann Gleason, CFM

Overview: Sarah provided a comprehensive update on the ongoing legislative session, focusing on public health funding and policy outcomes.

- The Christmas Tree Bill (HB 5006) included no additional funds for coalition priorities but did allocate \$1.2M for the <u>LUBGWMA</u> Project in NE Oregon.
- Public health modernization was on the funding list before the revenue forecast, but no additional funds were allocated due to budget constraints.
- Behavioral health and housing were session priorities, but even these areas received only a fraction of the requested funding.
- Positive note: No cuts to public health, and a cost-of-living adjustment (COLA) was received.
- Policy updates included the passage of a gun control measure (SB 243) and progress on bills related to tobacco and vape regulation (HB 2528, SB 1198, SB 702), with mixed outcomes.

Debrief/Discussion: (following page)



- Discussion on alternative funding sources for public health, such as fuel and cannabis taxes, and the challenges of reallocating these funds.
- Consideration of alcohol tax increases, with the consensus that significant progress is unlikely until a future long session or via ballot measure.
- Inquiry about local public health levies; Benton County shared its experience with a health and safety levy.
- Members discussed the feasibility and political challenges of securing new funding streams for public health.

Representation on Boards: Opioid Settlement, ADPC LPHA & Comm | Updates, Possible VOTES | Sarah Lochner, CLHO ED

Overview: The group discussed representation on the Alcohol and Drug Policy Commission (ADPC) and the importance of local public health administrators (LPHAs) having a voice.

- House Bill 2929 is expected to be signed, granting a voting seat to an LPHA on the ADPC.
- The ADPC meets monthly, with subcommittees open to staff participation.
- Criteria for the representative: must be an administrator with expertise in communicable disease, harm reduction, and prevention, and not have been at OHA during the 2016 prevention merger.

Debrief/Discussion: There was emphasis on the need for diplomatic representation and healing relationships within the prevention community.

VOTE: Tim Lynch (Coos) was nominated and approved (Tim abstained) to be the representative to the ADPC after a motion and second.

CLHO Retreat Program | Discussion | Sarah Lochner, CLHO ED

Overview: Sarah reviewed the planning updates for the upcoming CLHO retreat (September 15–17, 2025), with board meetings occurring on the third day, September 17.



- The retreat will focus on public health modernization, with Day 1 dedicated to education and discussion of the modernization manual, and Day 2 focused on visioning and addressing uncertainties.
- Homework assignments include reviewing the modernization manual and evaluation documents.
- The retreat will feature presentations from the Public Health Accreditation Board and small group discussions.

Debrief/Discussion:

- Discussion on the interconnectedness of visioning efforts across groups (CLHO, PHAB) and the importance of a shared vision.
- Clarification that the product of these sessions (framework, report, or vision) is still being defined.

OHSU/PSU School of Public Health Workforce Training Input | Update/Discussion | Dean Paul Halverson, OHSU/PSU SPH

Overview: Dean Paul Halverson and Steve Godenheimer presented on the school's efforts to support local public health workforce development.

- The school is celebrating its 10th anniversary and is focused on anti-racism, health equity, and workforce training.
- Initiatives include an online MPH in public health practice, curriculum redesign to ensure foundational public health knowledge, and increased opportunities for internships and practical experience.
- The school is seeking input from local health directors to better align training with workforce needs, including rural health and surge capacity.
- Dean Halverson also shared that there's a new academic health department partnership with Multnomah County.

Debrief/Discussion:

- Q&A covered certification requirements, the need for public health administration training, and the challenges of workforce shortages.
- Suggestions included developing asynchronous Public Health 101 courses and environmental health fundamentals.
- The school is open to further collaboration and site visits to understand local needs.



Member Announcements | Updates | CLHO Board Members

Overview: Member announcements were interspersed throughout the meeting, with acknowledgments of hard work, expressions of gratitude, and updates on local initiatives.

- Recognition of CLHO staff and collective efforts during the legislative session.
- Sharing of experiences with public health levies and workforce development.
- Encouragement for ongoing collaboration and communication between local health departments and academic partners.
