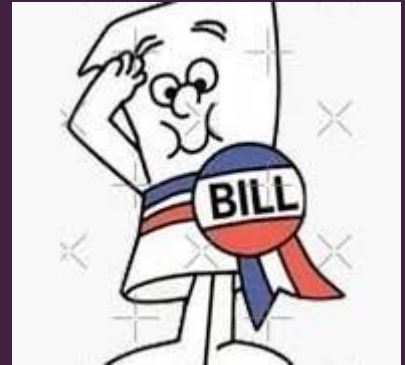
# Legislative Updates:

**HB 2701:** Directs LPHAs to maintain capacity for the following for 120 days at 25% mortality rate - WATCH for now; likely won't pass

**HB 2943:** CAP bill for mandatory ED tests for HIV & Syphilis - OPPOSE unless amended; likely dead, therefore no FIS coming

**HB 2048:** Food carts & commissaries - dead

**SB 161:** CLHO's workforce bill
