Main Subject

CLHO Systems and Innovation Committee Charter Work Plan Development

Public Health Modernization aligning with Oregon's governmental Public Health Systems continue on the Modernization journey and work to align community needs and program elements. Starting a discussion to add land use planning along with health Environmental Justice.

**Decision** Will be working on lining up public health manual with the charter.

Action Item #1: (Responsible Person): Andrea Hamburg will work with Kathleen Johnson to facilitate the charter discussion.

Main Subject

Gabriella Goldfarb spoke with the group regarding some bills from the 2018 legislative session. SB 1541 which Authorizes Environmental Quality Commission to adopt program and rules to reduce public health risks of emissions of toxic air contaminants from industrial and commercial air contamination sources. SB 1550 which Authorizes State Fish and Wildlife Commission to adopt record keeping requirements for person engaged in taking, landing, buying or selling of food fish for commercial purposes or otherwise dealing in food fish for commercial purposes. HB 4001 Requires Environmental Quality Commission to adopt by rule program that places cap on greenhouse gas emissions and that provides market-based mechanism for covered entities to demonstrate compliance, and HB 4003, requires certain public improvement contracts to meet certain requirements related to use of diesel engines in course of performing public improvement contract.
