Measure 108 Tobacco Tax Dollars	Jennifer and Linsey lead a conversation about measure 108 and tobacco tax dollars. There is approximately \$10million unallocated and the state is allowing LPHAS to receive those dollars on top of regular TPEP. The HPP committee has been asked by OHA and JLT to determine a proposal on how to allocate remaining 108 dollars. OHA has said to keep in mind work with increasing capacity, CBOs, equity, and flexibility. It's too large of a topic to cover in just the HPP meeting, so an ad hoc meeting will be held.	& Lindsey
PE 62 & CBO Funding Decisions	Courtney Fultineer form OHA's Injury & Violence Prevention Section presented proposed changes to Program Element 62: Overdose Prevention. These changes expand allowable activities to include non- opioid overdose prevention activities (e.g., stimulants) add an optional activity related to supporting the coordination of local opioid settlement resource allocations, and add a high-level description of the public health problem and burden of disease related to overdoses.  The Subcommittee reviewed the proposed changes prior to the meeting. An additional change was proposed related to including evaluation as an allowable activity for local overdose emergency response efforts. The Subcommittee recommended sharing the revised PE with Regional Overdose Prevention Coordinators before advancing the changes to the larger CLHO.  Courtney will incorporate the Subcommittee's

SAPT Block Grant Funding Update	HPCDP staff, Stephen White, Amanda Cue and Leah Festa, recapped efforts to date and described next steps in the process as detailed in the 3/11 email with "SAPT BG COVID prevention Funding next steps 3.11.22" document. OHA plans to finalize the overall investment strategy (Feb-March), explore funding scenarios and share back the scenario for distributing funding to existing grantees (March-April), and begin amending financial agreements for ADPEPE grantees (March – May).  The funding allocation for County ADPEP was shared in a 3/25 email with a "SAPT BG one-time funding	Amanda Cue & Leah Festa
	distribution summary". This document details the amount of funding available for each county ADPEP program based on the current funding allocation formula used for the Substance Abuse Prevention and Treatment Block Grant (SAPT BG) primary prevention funding (your program's current ADPEP budget).  HPCDP will offer two optional office hours for ADPEP grantees to ask questions and connect with colleagues about this funding. These office hours will be held at the following times: April 13th from 3:00 – 4:00 and April 15th from 9:00 – 10:00. HPCDP will share out additional guidance next week (sent on 4/11) for ADPEP programs to provide updated workplans and budgets by May 11, 2022.

Measure 108 CBO Awards	The Oregon Public Health Division (PHD) released a Request for Grant Applications in December 2021 for community-based organizations which included funding for commercial tobacco prevention (Ballot Measure 108) along with 7 other public health programs. OHA received 114 applications for commercial tobacco prevention funding with budget requests totaling more than \$43 million. After a competitive review process that included 8 external community advisors, PHD is funding 72 CBOs for commercial tobacco prevention activities at nearly \$19 million.  PHD also set aside 1.0 million in commercial tobacco prevention funding for additional outreach and funding to CBOs serving rural and frontier communities in collaboration with LPHAs. PHD is now working with the Conference of Local Health Officials to determine BM 108 funding allocation for LPHA's to further strengthen equity efforts and expand capacity to work in partnership with CBOs and other tobacco prevention system partners. PHD can provide CLHO with a final list of awarded CBOs as organizations who were offered funding accept/decline and finalize budgets and workplans in April and May 2022.	Steven Fiala
