1. Welcome & Introductions

3. Alcohol and Drug Policy Commission (ADPC) Participation - HB 2929

- Presenter: Jennifer Little, Klamath County.
- HB 2929 allows a public health representative on the ADPC board.
- Tim Lynch (Curry County) was nominated by CLHO as the representative.
- Discussion included:
 - o Importance of updates from ADPC to this committee.
 - Suggestion for Tim to provide regular updates once appointed.
 - o Interest in two-way communication between CLHO and ADPC.

5. Legislative Bill Updates

- Sarah Lochner, CLHO, shared that the legislative session outcomes were disappointing; the seat on the Alcohol and Drug Policy Commission was the main win during this last session.
- ADPC received funding for a statewide prevention plan.
- Discussion on the future of the flavored tobacco ban:
 - Legislative support is currently lacking.
 - o Strategy may need to shift to a longer-term approach.
 - Washington County's flavor ban is pending a decision from the Oregon Supreme Court.

6. Next Meeting Agenda Topic(s) Discussion

- Members were encouraged to submit agenda items early for the next meeting.
- Suggestion to revise the "Legislative Updates" standing agenda item to "Strategic Planning Around Legislation." This time will be used to discuss possible strategies for the upcoming legislative session.
