HB 2395 Update	Overview	Courtney provided an update on HB 2395's youth/young adult overdose reporting requirements. The new reporting requirements are part of the larger Opioid Omnibus bill that passed in the last legislative session. The new requirements are like existing suicide reporting requirements for deaths among individuals 24 years or under. However, HB 2395 only requires local death notifications; postvention response activities are optional but not required.  As of January 1, 2024, district medical examiners or medical-legal death investigators must notify the local mental health authority in the county where the suspected youth/young adult overdose death occurred. OHA is working with the nine Federally Recognized Tribes to determine their preferred notification process when the decedent was a Tribal member.  OHA was required by statute to develop Communication Guidance to assist local notifications by January 1, 2024. Given the tight timeline, OHA has released initial guidance but will engage local public health, local mental health, and Tribal partners throughout 2024 to iteratively update and improve the initial Guidance. PE 76 TRL Updates		Sarah and Annie gave a short overview of proposed changes to PE 76. TRL PE 76 went into effect on July 1, 2023. It provides local administrations to do tobacco inspections, and work with OHA to issue civil penalties and tobacco retailer oversight. The pertinent issue to address in amending PE 76 is to suggest timelines and clarify the expectations. Sarah and Annie would like the committee to vote and approve the changes to move forward to big CLHO.  Annie went over the changes to the timeline and recording period which include procedural and operational requirements. The six counties that have participated include: Clackamas, Coos, Curry, Douglas, Hood River, and Josephine. Belinda with Hood River said that the proposed changes would be helpful to clear up some issues they have struggled with in their county.
