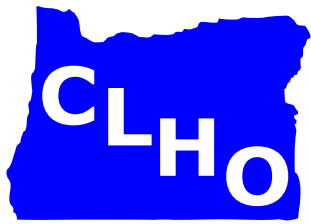

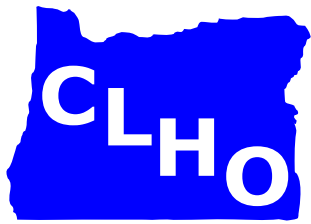

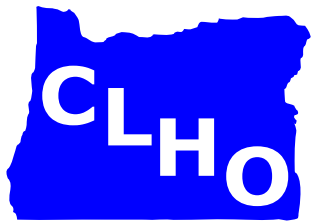

		<p>funding request began with PHAB’s work in 2022. A broad view for modernization came out of the pandemic including a need to develop a public health workforce and adequate funding to accomplish PH goals. There was \$286 million requested in the OHA Agency Request Budget, and Governor Kotek included \$50 million in the 2023 – 2025 Governor’s budget. The Governor’s budget is a starting point for the Legislature, which is responsible for adopting OHA’s budget by the end of Legislative Session.</p> <p>At the direction of the Public Health Advisory Board, OHA convened a workgroup of PHAB members, health administrators and CBO representatives in December and January to develop a set of funding scenarios that articulate priorities and allocations to partners at a range of funding levels. Based on workgroup discussions, with a \$50 million investment Oregon would prioritize PH investments in workforce, community health, equity, communicable disease. Also in these discussions, CBO representatives and health administrators emphasized the need to allow flexibility in using funds for prevention priorities including social determinants of health (SDOH).</p> <p>Based on the workgroup recommendations, the funding scenarios include proportional reductions in allocations at \$50M to the allocations that were originally included in the \$286 million funding request. At \$286 million, allocations included \$100.3 million to LPHAs, \$100 million to CBOs, \$30 million to Tribes and NARA, \$10 million for the reproductive health provider network, \$3.5 million for community-led data initiatives and the remainder for OHA. A concern of the committee was that LPHA and CBO’s work alignment can be challenging in collaboration with the counties.</p> <p>The committee would like to have Sara return for an ongoing discussion of modernization.</p>

These include:</p> <ul style="list-style-type: none"> • Diabetes (Continuing 5 year) • Arthritis (Continuing 5 year) • Cardiovascular Health • Alzheimer's/Dementia • State Physical Activity and Nutrition Program (SPAN) <p>The grants provide support in sustaining funding relationships with LPHA's through PE 4. JUUL Stipulated Judgement		<p>Sarah Wylie shared information about the JUUL stipulated judgement. Thirty-three states sued JUUL for the financial burden to the state contributed by their product. Oregon was one of the lead states and will receive \$18 million dollars over seven to 10 years. DOJ is the lead agency with the first payment being distributed to DOJ in December.</p> <p>There was a parallel lawsuit that included the schools and tribes of Oregon.
