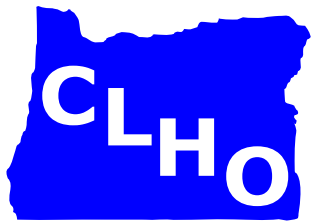

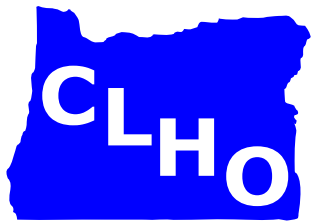

| <p>LPFA TPEP Underspent Budget Ideas for Approval</p> | <p>Decision</p> | <p>Lily Banning circled back with committee members on how to spend the \$400,00 left over from the TPEP budget for the 23-25 biennium. She went over ideas presented in the attached PowerPoint. Recommendations will be reviewed and considered in an internal HPCDP budget meeting on 9/19. Jessica thought it should go to big CLHO so the administrators would be kept in the loop. Jennifer will email PHAO to advise about the extra funding and spending. Tim said the committee could make the recommendation and then it could go to CLHO. Suzie mentioned the survey from HPCDP TPEP. Lily explained the survey was informal and anonymous, asking TPEP Coordinators to select which funding ideas they would like to prioritize. A consensus of the committee was that funding should be dispersed to the counties and allow them flexibility in how the money is spent. Members did not want the funding criteria to be cumbersome or heavy on administration. A vote was taken, and it was recommended that the modernization formula for tobacco be used for the county's allotment. | LPHA Overdose Prevention Funding Update | Update | <p>Tim and Laura provided an update on the overdose prevention funding status. Tim reported that the state substance abuse block grant would cover the gap due to reallocation of State Opioid Response grant funds. Tim said the block grant funding is secured through FY25. OHA will communicate via email with workgroup members, LPHA administrators and overdose prevention coordinators regarding funding levels.</p> | Laura Chisholm and Tim Noe |
| Discuss OHA's Overdose Response Protocol | Discussion | <p>Laura introduced and reviewed the history of the State Overdose Response Protocol. Dating back to 2018, the protocol was created with input from Oregon Health Authority (OHA) staff across the agency, representatives from 15 LPHAs, Oregon Poison Center, Lines for Life, and Outside In. Approval and input from OHA leadership was delayed due to COVID-19. The current goal is to work with LPHAs to coordinate and align processes, communication, and collaboration in response to the rapidly changing overdose landscape in Oregon.</p> <p>Savanna and Courtney are convening an ad hoc work group that will meet for two 1-hour sessions, 9/26 from 1-2p and 10/3 from 1-2p, to discuss the intersection of the State Overdose Response Protocol and LPHAs. If you are interested, please email Savanna (savanna.santarpio@oha.oregon.gov) and Courtney (Courtney.fultineer@oha.oregon.gov) directly to express interest. | | | <p>- Other questions/concerns from LPHAs?</p> <p>Suzie asked about counties that needed additional support from their partner agencies with OD mapping resources. This work is supported by Oregon-Idaho High Intensity Drug Trafficking Area (HIDTA) partners and a warm handoff may be provided upon request. Suzie wondered if the state would be available to assist the counties like with the covid response and if counties feedback had been incorporated with the protocols? Courtney responded that county feedback is a critical resource that informs the current iteration of the State Overdose Response Protocol. OHA has been piloting and refining this protocol with recent notifications of suspected increases in Oregon counties and statewide.</p> <p> Oregon State Overdose Response</p> | |
